


LEGAL DESCRIPTION OF DOWNTOWN CROSSING AREA

A CERTAIN PARCEL OF LAND CONSISTING OF 11.40 ACRES LOCATED IN THE CITY OF NEW HAVEN, STATE OF CONNECTICUT AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:
