- -Attorney Rini said we can include use of 10% for New Haven businesses in the Authority's bid documents subject to State approval. Attorney Merin concurred.
- -Attorney Rini said we need to get the State Grant started by January in time to get our contracts out for bid.
- -Attorney Rini said the discussion points noted in the chart were presented to inform the Commissioners on where the Authority is on updating their contracts to comply with the State requirements for the Grant. He said this work can be credited to Mr. Staniewicz and Attorney Merin, and they have done an exceptional job.
- -Commissioner Stewart said he appreciates and wanted to thank Commissioner Hausladen and Mr. Staniewicz for their time to review, make changes and have an open mind on this issue.
